Tech Session

Harold Weaver displayed a modified Guillows rubber powered model for indoor flying. The enhancements included a larger rubber band, rudder adjustment and dihedral to the wings.

Safety Managers Report

Again we have to report another unfortunate incident resulting in an injury. While hand launching his Slinger, Emery had his launching hand get scraped by the propeller resulting in 20 stitches. The Slinger is a flying wing type of pusher plane with engine facing toward the back of the plane. There is place to hold it under the fuse and throw it but you must absolutely follow through on the launch. This is the third propeller incident of the resulting in one of our club member pilots having to endure severe gashes requiring stitches.

Field Managers Report

- The Zero Turn mower blades were taken to be shortened but they were found to be too short and new blades will need to be purchased.

Important message from GSLMA President below about Buder Park for RC and CL flying. Buder is the only St Louis County Park where RC and CL flying is authorized. To fly there you only have to have a AMA license and a Buder Park Permit, cost \$35 per year. Park Rangers will now be making spot checks to be sure flyers have a Buder Permit. All money collected is used to pay for AMA Insurance and maintenance of the RC and CL facilitates.. In most cases GSLMA pays for maintenance materials and the Parks Department supplies the labor.

Also note that roadway access to Buder Park is in the process of changing due to extensive changes being made to the Hwy 44/Rt 141 interchange.

We all use CA and if not used in a timely manner it dries up. A method to eliminate that is to buy pipettes, fill it with CA and then seal the edge by melting with a soldering iron. It will stay fresh for a long time.


I propose a club purchase. If we get 10 people for 5 dollars each, each would get 50, if 5 people at 10 dollars each you get 100.


Club members,
