#### Minutes of the Phantom Flyers RC Club meeting on 18 January 2021

The meeting occurred via Zoom and was opened by VP Dan Dierking at 6:30 PM. Nine members were present. President Bill Ahrens is in quarantine, in a hotel in South Korea. Bill may be allowed to return to the US in late March.

Don Grzina led a tech session where he described cutting a replacement carbon fiber landing gear plate for his Acuity pattern plane. Apparently the "Yak Spit" that was used as adhesive in the manufacturing of the stock plywood gear plate was insufficiently cured. Don found a local shop that would use their water jet cutter to cut out the plate but this resulted in severe delamination's around holes. Don then cut and drilled his own plate using a 1/8" carbide router bits and carbide table saw blade. The morale of the story is never pay someone to screw your stuff up when you can screw it up yourself for free. Actually, Don's replacement plate looks well up to his fine standards of fabrication.

Secretary Report - We now have 27 regular members. A motion passed to accept the minutes of the December meeting as reported in the Carrier Wave.

Treasurer's report - Jose reports we have about a \$3600 surplus (over and above the \$5000 needed for field lease)

Safety Officers Report - Safety Officer Dave Evans has nothing to report.

Field Manager - Field Manager Don Grzina also had nothing to report.

## Our Seasonal Non-Flying Time


Club members have been busy prepping and/or repairing models for the 2021
