Activities Report: There is a need for a person to be the event leader for the Open House this year. 2024 Schedule has been posted. No comments or corrections have been reported. 2 Meter Glider contest will be held Sunday April 7th.

GSLMA Report: Harold reported there was no meeting in February.

Old Business: Update on the FRIA sites, the module requirement was changed to March 16, 2024 at non FRIA sites. The Height limit is now 700 ft at FRIA sites and can be raised to 1200 feet with approval for events.

FAA Inspection (RCGroups)

I found this interesting thread on RCGroups. It was dated 3/28/2024 and now goes on for multiple pages and here is a link. https://www.rcgroups.com/forums/showthread.php?4526715-FAA-Inspection

"To whom it may concern, I'm sharing this information so that pilots are aware that FAA inspections are a real thing. It's your responsibility to be compliant with the law that has gone in to effect less than two weeks ago, March 16th. My hope is this thread is used to report inspections and not a discussion of ones opinion of the law. Thanks.

In Connecticut Wednesday March 27th an FAA inspector arrived at an AMA club's flying site and checking that the pilots had a TRUST copy, FAA Registration Number card, and the FAA registration number on their model aircraft. Please advise any clubs and members. AMA will be getting this message out sometime today. The FAA hasn't given anyone a citation as far as we know. They may issue a warning. It is not the AMA's intention nor should it be the club's to enforce the FAA regulations. It remains the responsibility of each member to comply.

UPDATE - Good News Not an Intended FAA Inspection:

I received a call from a member who was at the site when the FAA inspector arrived. The good news is that this was not an FAA-planned inspection of AMA flying sites or member's flight operations. The FAA inspector told the AMA members that his office had received a complaint that people were flying model aircraft without FAA-affixed registration numbers and who did not have FAA Trust Completion Certificates. The inspector advised the pilots that this was the law and that they needed to remain at altitudes below 400 ft. and would also require Remote-ID compliance. The members attempted to explain that they were flying as AMA members which led to them calling the AMA to have someone more knowledgeable speak directly to the FAA inspector.

Unfortunately, AMA's Gov. Team Director, Tyler Dobbs, and Chrystal Pearson were in Washington and someone else took the call. The person from AMA HQ did her best to explain the exemption status and requirements of how AMA members are allowed to operate their model aircraft. The FAA inspector had some differences between what he was hearing from AMA HQ and those members at the site. He said that what he was telling them was the law and required compliance.

I called Chad and as many of you have suggested the AMA will be looking to provide a better process to handle situations like this not only from HQ but at the club and member level. We will engage in further collaboration with AMA staff, the EC, district officers, and clubs to create a process that utilizes specific messaging to address the issues most likely to occur for clubs and members conducting flight operations under AMA's exemption as provided in the FAA regulations."

I have the 'Trust' certificate in my transmitter case and my models have the indetification labels on them and a couple of spares in the case.




Members Projects/Tech Session

Club member, Dan Eaton 3D printed a F-4E Phantom to be used as a static display for a friend. The original design work was done by a modeler in Switzerland named Simon. It was a bit smaller and intended to printed in LW-PLA (Light Weight-PLA) and flyable as a single 80mm EDF model. Dan enlarged the model, to 72" long, and printed it in PLA. Dan says he increased the original design by 130%. At this size it is a 120mm EDF class.

So what is involved? I asked Dan to give us a breakdown;

'I started printing the nose section back on 1/31/2024. The nose takes about 10 hours to print and I did it twice because I found under extrusion on the first print. The remaining sections on the nose take six or seven hours to print. Once you get to the main body, print times jump up into the three- or four-day range. Of course, that's when under extrusion struck again so I had to reprint one section after it was about 90% complete. There was a lot of times where I would start a print, find something was wrong after a couple of hours and then have to start again after tweaking the parameters. Lots of work, but the end result is amazing.'





Dan, also has a number of 3D printed models in various stages of completion. This includes a BAE Hawk, Boeing T-7 and a F/A-18.
