AMA Announcements:

Based on the following, some area clubs are receiving e-mails from the AMA changing their flight ceiling. To date we know the Wright Flyers and the Signal Chasers in Pacific, MO have received a notice. I am sure more are on the way. Great news for the hobby!

AMA Members,

AMA is excited to announce that we have been granted a National Authorization allowing our members at AMA club sites in Class G airspace to operate above 400 feet above ground level (AGL) for routine, day-to-day activities. Based on your location in Class G airspace, your site will have a new altitude limit of up to 700 feet or 1,200 feet AGL. To determine at what altitude you can fly up to at a flying site, use this guide.

This is an exciting step toward easing restrictions for our members who enjoy this great hobby. As we march forward, AMA will continue to work with Congress and the FAA to further ensure that our members across the country can enjoy the freedom of flight.

Members can view the National Authorization here. Please note that operations above 400 feet in Class G airspace are not permitted until the flying site obtains a copy of this authorization, as well as meet the outlined criteria within the Authorization. Club officers should make sure to keep a copy of the authorization on file with the club's records. Additionally, AMA will be publishing an FAQ guide to address questions and/or concerns that members might have regarding the authorization.

The following information came from the Signal Chasers R/C Club in Pacific, MO. I am sure we will get more information from Harold, our GSLMA Rep when he returns from vacation.

Greetings Buder Park Flyers!

There is an annual Buder Park Flying Permit available for \$90 using the process and form attached to this email.

In order to be issued an annual Flying Pass at Buder, you will need to complete the contact section of the attached form. We will then input you as a user in the park system and you will be sent an online payment link. You can pay immediately with a Visa, MC or Discover. If you prefer to pay via check, you can mail a check made out to St. Louis County Parks and Recreation to my mailing address below. Once payment is made, you will be mailed a personalized, brightly colored permit to be placed on your dash when you are at the park. Below are some FAQs.

- 1. The passes are good for the year, January 1-December 31
- 2. The hours are dawn-dusk
- 3. We anticipate black out dates for flying group events, cross country meets, etc.
- 4. The pass is not prorated for events or flooding
- 5. Daily passes are \$6/person to be paid at the park, in cash, the day you use the field. (There are envelopes and an 'iron ranger' to take payment on site)
- 6. If you are just spectating, no pass is needed
- 7. For insurance requirements and to see the park policy, please visit- https://stlouiscountymo.gov/st-louiscounty-departments/parks/about-us/park-rules-regulations-and-policies/model-sports-drones-rocketryand-other-aerial-activities/

For Rocketeers: NAR Members have \$5 million insurance; TRA members have \$3 million insurance. Make sure to have your membership cards with you at Buder.

Winter Flying in Foley Alabama – Harold Weaver

These are 3 photos that show the results of my loss of signal to my 1.2 m E-flite Slow Ultra Stick.

The first is the condition of the Stick when it was found. It appears to have been a steep dive after I lost sight when it was about 20 ft in the air. It impacted the wet soft ground left wing tip first which spun its nose into the ground driving the nose 6 inches into the ground and then settled back into an upright condition as you can see in the photo. Both blades of the prop broke off as the motor went into the ground including the full length of the battery. The battery was totally discharged after setting for 2 days. There was no damage to the motor and it and the 6 inches were easy blown clear of debris.

The only real damage was to the left-wing aileron hinging and a chunk of foam that broke off from the wing root as you can see in the photo. The aileron hinge was easily repaired with Blenderm tape and I elected to temporarily install a new left wing as you can see in the photo. I will replace that chunk of foam when I get home and then reinstall the repaired wing in place of the new one. It is a very sturdy airframe and very easy to fly and even though it has thick non-symmetrical airfoil with a little dihedral it is fully aerobatic and in the hands of an experienced 3D pilot like Brian Malloy I'm sure it can be really wrung out.

Although it's ready to fly as shown in the photo I'm not sure I will get to fly it again until I get home to St Louis because even though we have warm weather here where I fly with the SARCM club in Foley, AL it is very windy and gusty almost every day.

Meeting Minutes Phantom Flyers R/C Club Meeting Minutes – 17 March 2025

Attendees: 9 club members were in attendance. Meeting called to order at 7:00 pm. Members were Ed White, Bill Reape, Harold Weaver. Dan Abel, Don Grizina, Jose Espinosa, Bill McMenamy, Wes Wallin, Bill Ott.

Secretary's Report: There were no questions or changes. There was a motion by Don G and seconded by Bill Ott. The minutes were approved.

Treasurer's report: Jose reported the account has is at \$9,500.00 so far.

Discussion on the budget followed. AMA sanction fee is increased, Ed added more for the Open House. Bill M. asked about the total account as it relates to the budget. Ed stated the account should be at \$1600.00 after all of the items on the budget are completed, approx. Bill R. made a motion to approve the 2025 budget. Wes Wallin seconded, all approved.

Safety Report. No reported incidents.

Field Managers Report: Don G. said he spent 3.5 hours using the roller on the field. It worked well. He suggested that all of the people mowing this year meet at the field sometime to review and learn how the mowers are started and operated. Repairs and sealing on the runway will be done early spring to avoid the hot temperatures. To avoid the trailer for the sealing material and pulling vehicle doing damage. Bill R mentioned Rich Jenkins has the manual for the new mower. Discussion about the parking area were mentioned. Because of poor drainage and very sandy soil the parking area is good as it can be.

GSLMA Report: Harold reported the parks department has a website and a box at the field to pay a \$6.00 fee per day. You also can purchase a \$90.00 yearly pass. GLSMA is planning to work or replace some of the stands at the field. Fred Cromwald is offering to help but it's the parks department doing things. Harold said the box may not be a secure way to pay. Wes W. stated the website works well to pay fees.

Activities Report: Dan Abel reported the schedule is on the website. The 2 meter contest April 6, and the Open House in May are coming up. Bill Ott asked about a Swap Meet this year. Ed mentioned the open house is having a "bring what you want to sell" during the Open House. We no longer have the venue for the Club Swap Meet.

Old Business : Ed mentioned the Leader Club application with the AMA is almost complete. The Grant process for may have a small advantage as a Leader Club.
